- 3. Interested bidders should contact the Administration Office for inspection of the assets for disposal at the LVBC offices at the New Nyanza Regional Headquarters, before the bidding deadline of **24th June 2024.**
- 4. Late bids, portion of bids, electronic bids, shall not be accepted for evaluation irrespective of the circumstances. Bidders may bid for one or more complete category but not in portions of a category.
- 5. The Buyer shall collect the assets within seven (7) days after full payment for the assets has been received by the Commission.
- 6. The buyer is responsible for all payment of duties and other related taxes on motor vehicles and any other assets as may be required.
- 7. The Commission shall release the vehicles after payment of respective duties and taxes to the Revenue authorities.
- 8. The buyer is responsible for all handling, transport and insurance to remove goods from their current location.
- 9. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below.
